Dear Parent/Carer,

We are offering an amazing opportunity to visit to Poland, and experience Krakow and Auschwitz. This is a 4 day (3nights) visit from 11<sup>th</sup> – 14<sup>th</sup> April 2019. To ensure good value this visit will take place in the Easter holidays but will travel on the last day of term (Thursday). Our aim is to offer this enrichment opportunity to enhance students' appreciation of the Holocaust. The trip ideally supports GCSE History students who study Nazi Germany and WW2. It should be noted that this is a voluntary enrichment trip and is not therefore an essential part of the History curriculum.

It should be noted that the nature of this trip can be a highly emotive and sensitive experience for students. The excursions are to places that demand respectful and mature conduct at all times. This is a very popular trip and places are limited. Places are allocated on a first come first allocated basis however staff reserve the right to preference students with an appropriate study interest and decline places if a student's conduct or effort is in question.

Unfortunately, the academy cannot meet the full cost of the trip. A parental contribution is required for the trip to be realised. The visit will therefore cost £585 and includes flights to Krakow, an excursion to Auschwitz Birkenau, Wieliczka Salt Mines, Wawel Castle, Rynek Grownny and the Schindler Museum. Overnight accommodation is on a half board basis in the 3\* Hotel Batory. All entrance fees and transport costs are included in the cost. Should this cost be prohibitive for your child then please contact the school to enquire about how we can support your child. In the unlikely event that there is insufficient uptake for the visit making it financially unviable we will regrettably have to cancel it.

It is important that we confirm our booking by 10<sup>th</sup> November and secure the flights and hotel at this good price. We realise this is a tight deadline however the flights can only be held for 2 weeks. If there is an issue with payment of the deposit, please contact Miss Wikocki. Once the flights are confirmed you will be provided with further details on dates, flight details and correct costings of airport transfers and a date for a parent meeting.

Please complete and return the attached reply slip, clearly stating the name of your child and how this appears on their passport and inform us of any changes in your child's medical condition or requirements. **To apply for a place on the trip, a deposit of £150 must be paid on parent pay on or before Monday 5<sup>th</sup> November and a completed reply slip and a photocopy of the passport and EHIC card submitted to Miss Wikocki.**

If your child is successful in gaining a place, the deposit will be **non-refundable**. If your child is unsuccessful the deposit payment will be returned.
